

# RULES OF THE POSTER / ILLUSTRATIONS COMPETITION ORGANIZED BY DOM KULTURY „13 Muz” CULTURAL CENTRE in SZCZECIN

## § 1

### GENERAL PROVISIONS

1. The organiser of the competition for the best poster or illustration concerning the creativity of Stanisław Lem, hereinafter referred to as the "Competition", is the "13 Muz" Culture Centre, with headquarters at 2 Żołnierza Polskiego Avenue, 70-551 Szczecin, taxpayer id NIP 851-00-08-312.
2. The aim of the Competition is to award and distinguish the best poster or poster design, an illustration inspired by the works of Stanisław Lem.
3. The competition is open to adults, both graduates and students of art faculties and amateurs.
4. Information about the Competition is published on the website [www.13muz.eu](http://www.13muz.eu) and facebook profile / 13muz.
5. The competition lasts until August 15, 2021.

### TERMS AND CONDITIONS OF PARTICIPATION IN THE COMPETITION

A participant of the Competition (hereinafter the "Participant") may be any person who meets jointly all of the following conditions:

1. Is an adult and the project he/she submits does not infringe personal rights and property of third parties.
2. In the event of a breach of copyright, bears full responsibility against claims in this respect.
3. Has read the regulations, accepted the regulations, and has filled in and signed **competition form**, which is then sent together with the design on time.
4. The declaration should be attached to the application in the wording constituting **Appendix 1** to these Regulations.

## § 3

### RULES OF PARTICIPATION IN THE COMPETITION. COMPETITION STAGES

1. The competition is open to persons who, by August 15, 2021, fill in the form correctly and submit the design in an appropriate digital form (format 70 x 100 cm, 300 dpi, CMYK) to the e-mail address: [lemostrada@13muz.eu](mailto:lemostrada@13muz.eu).
2. Files sent to the competition should be named without Polish characters as in the formula: Title\_initials\_poster\_1, Title\_initials\_illustration\_1. If the author submits more than one work, posters / illustrations should be marked with successive numbers at the end of the file name. Files can also be sent via weTransfer.
3. Each participant may submit up to three designs in a given category, i.e. a poster or an illustration.
4. Submitting the application is tantamount to accepting the terms of the Competition.
5. The application is considered valid when it meets the conditions specified in the regulations.

## § 4

### RULES OF THE COMPETITION ASSESSMENT

1. In order to ensure the proper organization of the Competition and the selection of the winners, a Jury will be appointed consisting of at least three people, including one

representing person - The Organiser of the Competition and two people dealing with professional design graphics.

2. The submitted questionnaires will be assessed by the Jury appointed in the composition announced at [13muz.eu](http://13muz.eu) / [facebook.com/13muz](https://facebook.com/13muz)
3. The Jury's decision is final.
4. The list of the Competition laureates will be published on the website [www.13muz.eu](http://www.13muz.eu) / [facebook.com/13muz](https://facebook.com/13muz). Additionally, the Competition winners will be notified of the win via e-mail within 7 days.

## § 5

### AWARDS

1. The prize pool is PLN 3,500. The distribution of funds for individual prizes will be decided by Competition Jury.
2. The awards will be presented during the opening of the post-competition exhibition, the date of which will be chosen separately.
3. The financial prize will be transferred to the bank account indicated by the winner.

## § 6

### FINAL PROVISIONS

1. The organizer reserves the right to postpone the dates of individual activities within the competition as dictated by organisational reasons.
2. Any changes to the Regulations are effective from the moment the related information is published on the Competition website, i.e. [www.13muz.eu](http://www.13muz.eu).
3. In matters not covered by these Regulations related to the organisation and the course of the Competition, the decisions are made by the Organiser.

3. Personal data will be processed for the purposes related to the organisation of the competition and the transfer of prizes.
4. The legal basis for the processing of personal data is Art. 6 sec. 1 point a. of regulation 2016/679 of the European Parliament and of the European Council of 27 April 2016 on the protection of natural persons in relation to the processing of personal data and on the free movement of such data, and repealing the directive 95/46 / EC "(General Data Protection Regulation), this means that consent is expressed.
5. Personal data will be processed by employees of the "13 Muz" Culture Centre.
6. The data subject has the right to request access to personal data concerning him/her, as well as to rectification, deletion and processing restrictions including the right to transfer data.
7. The data subject has the right to withdraw his/her consent at any time. Withdrawal of the consent does not affect the lawfulness of processing based on the consent before its withdrawal.
8. The data subject has the right to lodge a complaint with the President of the Personal Data Protection Office.
9. Providing personal data is voluntary, but it is a necessary condition to participate in the competition. I give my voluntary consent to the processing of my personal data for the purposes related to the organisation of the competition, including publishing my name and surname in case of receiving an award.
